## Notes:

1. **Safer Streets Initiative.** Following the article in the LCDT newsletter the following comments have been received.
  - a. Edinburgh Road – extend 20mph zone from rail bridge to canal bridge
  - b. Edinburgh Road – create permanent segregated cycle path on north side of road from High Port to beyond canal bridge with adjustment to traffic lights.
  - c. Parking should be permanently forbidden between St Michael’s Wynd and the Four Marys. However, do not suspend parking between Lion Well Wynd and New Well Wynd but insert permanent bollards to prevent cars pulling too far forwards – see pictures.
